# Russell Bedford reports continued growth in IAB World Survey

Multi-award-winning global professional services network, Russell Bedford International, has reported some notable performance statistics following an analysis of the recently released International Accounting Bulletin's 2023 World Survey results, which includes fee data and growth rates of all international accounting groups.

Growing by an impressive 9% in 2022, Russell Bedford International has maintained its position as a Top 20 international network, while continuing to record the consistent growth it has demonstrated in recent years.

The network recorded the seventh fastest growth increase of all networks in the Top 20 and more than double the average growth across all international networks, outside the Big Four.

In four of its six regions, Russell Bedford was positioned in the Top 10 in terms of percentage growth achieved, with Asia reporting the 3rd highest increase of all Top 20 networks. Furthermore, the network recorded the 2nd greatest net increase in number of new member firms.



### Proposed GAAP Taxonomy improvements \* US focus \*

The Financial Accounting Standards Board (<u>FASB</u>) staff recently issued for comment proposed GAAP Taxonomy Improvements for a proposed Update to improve the accounting for and disclosure of certain crypto assets: Intangibles—Goodwill and Other—Crypto Assets (Subtopic 350-60): Accounting for and Disclosure of Crypto Assets (Release Notes).

The comment period on the proposed GAAP Taxonomy Improvements for the proposed Update ends on 6 June 2023. Interested parties may provide comments by sending their comments to xbrled@fasb.org.

#### **EFRAG** educational videos on ESRS

The European Financial Reporting Advisory Group (<u>EFRAG</u>) has published a series of educational videos on the <u>first set of European Sustainability Reporting Standards</u> (ESRS). The ESRS will be mandatory for a first set of companies in Europe (largest companies) from 2024, with a phased implementation over the following years.

The videos provide a concise introduction to the general requirements and implications of the ESRS, as well as a run through of the technical details of the standards. They are an important resource for anyone who wants to improve their understanding of the ESRSs, and for companies that will be implementing the ESRS for their corporate reporting in the coming years.

#### Technology-related revisions to the IESBA Code

On 11 April 2023, the International Ethics Standards Board for Accountants (IESBA) issued a <u>final pronouncement with technology-related revisions</u> to the IESBA Code of Ethics for Professional Accountants (including International Independence Standards (the Code).

The revisions were informed by extensive fact-finding and stakeholder outreach, and were developed to remain relevant and applicable in the ever-evolving landscape of technology transformation. They apply to the use of any technology, including to the extent possible, future technologies.
