The audit practice KBT Revisions AG, represented by partner Sandro Müller, has been a Russell Bedford member firm in Zurich since 2016. The practice has now merged into BSP Group, which has been confirmed as Russell Bedford's new Zurich member.

This consolidation has created a four-partner practice with a portfolio of over 120 audit clients under one roof.

BSP Group was originally founded in 2012 by Stephan Bertschi and Andrin Steinmann and provides services including accounting, payroll, tax, and audit. Following the merger, BSP Group is now a four-partner firm.
